The Company recently took delivery of an MR product tanker, STI Yorkville, from Hyundai Mipo Dockyard of South Korea. Upon delivery, this vessel began a time charter for up to 120 days at approximately \$18,000 per day.

Scorpio Tankers Inc. currently owns 46 tankers (four LR2 tankers, two LR1 tankers, eight Handymax tankers, 31 MR tankers, and one post-Panamax tanker) with an average age of 1.5 years, time charters-in 24 product tankers (eight LR2, five LR1, four MR and seven Handymax tankers), and has contracted for 29 newbuilding product tankers (14 MR, eight LR2, and seven Handymax ice class-1A product tankers), 15 are expected to be delivered to the Company throughout 2014 and 14 in 2015. The Company also owns approximately 16% of Dorian LPG Ltd.
